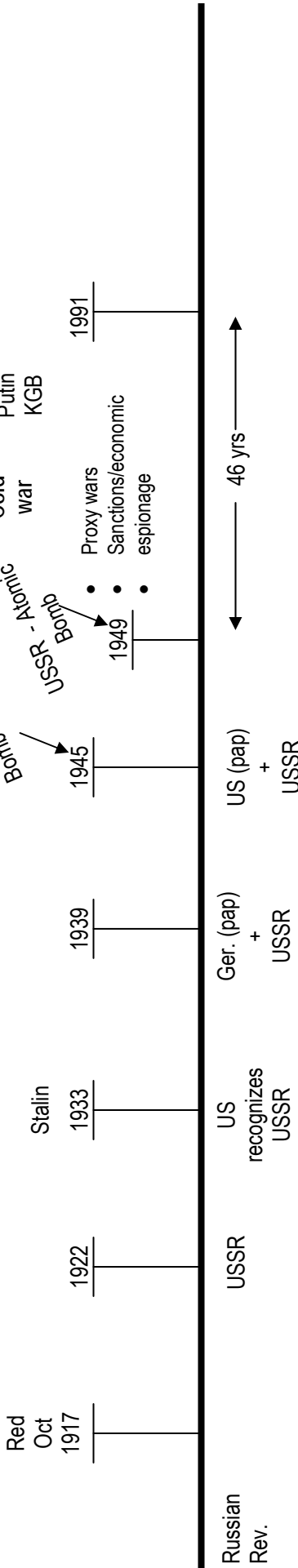


Birth of KS in 1917; under Russian Revolution, becomes Communist



Some secular commentators today say USA is in 1933 Germany. Prophetically we are in the history of WW2

- Hitler rose to power, then WW2

Papacy began working with US after failed with Germany

You want to have some control of countries around you to protect from impact

Churchill and Roosevelt allowed Stalin to have some supervision over E Europe. Stalin set up puppet Communist governments

The Iron Curtain was the name for the non-physical boundary dividing Europe into two separate areas from the end of World War II in 1945 until the end of the Cold War in 1991. The term symbolizes the efforts by the Soviet Union (USSR) to block itself and its satellite states from open contact with the West and its allied states. On the east side of the Iron Curtain were the countries that were connected to or influenced by the Soviet Union, while on the west side were the countries that were allied to the United States or nominally neutral. Separate international economic and military alliances were developed on each side of the Iron Curtain.

The Yalta and Potsdam conferences  
The Yalta and Potsdam conferences were called to help the Allies decide what would happen to Europe, and in particular Germany, at the end of World War Two.

Yalta - February 1945: Germany was not yet defeated, so, although there were tensions about Poland, the big three - Stalin, Roosevelt and Churchill - managed to agree to split Germany into four zones of occupation, and to allow free elections in Eastern European countries. Russia was invited to join the United Nations, and Russia promised to join the war against Japan when Germany was defeated.

Potsdam - July 1945: Germany had been defeated, Roosevelt had died and Churchill had lost the 1945 election - so there were open disagreements. Truman came away angry about the size of reparations and the fact that a communist government was being set up in Poland. Truman did not tell Stalin that he had the atomic bomb.

#### Side Note:

Afghanistan is right under Russian border. If US has troops in Afghanistan and controls that government, that's a problem for Russia. Putin doesn't want Nato to get closer to him. He wants to know his borders are safe, just like Stalin. A country in E Europe trying to join Nato, like Ukraine almost did—you know there is going to be a conflict. He wants to keep the areas surrounding him under his sphere of influence.

One reason Afghanistan becomes strategically important, on top of it being an avenue down to Asia, is location on Russia's southern border. Makes it a dangerous place to have American weaponry.



### AIDS VIRUS

- July 1983 India Newspaper: Patriot publishes: HIV Virus created by US government as a weapon to kill African Americans and homosexuals in Maryland
- 1985 picked up and published in Soviet newspaper. They're able to link back to India  
Spreads all over Africa. 2 E German biologists write a report backing that claim.
- 1986 Newspaper version of "gone viral"
- 1987 Mainstream US television

KGB agents required to spend 25% of time manufacturing disinformation. Part of your job description—to create false stories and inventing ways to spread them.

85% of KGB budget on espionage went just to manufacturing false stories— disinformation

#### 1985 Interview with KGB agent that defected to US:

"to change perception of reality of every American to such an extent that despite the abundance of information, no one is able to come to sensible conclusions in the interest of defending themselves, their family, their community and their country"

### COLD WAR: INTERNAL SUBVERSION

To change the perception of reality

It doesn't matter how much information you have, you can't come to a sensible conclusion

### PROPAGANDA: do we teach it?

information, especially of a biased or misleading nature, used to promote or publicize a particular political cause or point of view.

a committee of cardinals of the Roman Catholic Church responsible for foreign missions, founded in 1622 by Pope Gregory XV.

\*describes a missionary activity - original intent

Propaganda is the spreading of information in support of a cause. ... The word propaganda is often used in a negative sense, especially for politicians who make false claims to get elected or spread rumors to get their way. In fact, any campaign that is used to persuade can be called propaganda.

Merriam Webster

the spreading of ideas, information, or rumor for the purpose of helping or injuring an institution, a cause, or a person

Parminder: to create an emotional, not rational response

**BIAS** - to favor one position over another; to be partial

Propaganda = to propagate - to spread, generally used in agriculture

Not negative - we are trying to promote God's cause (missionary activity—original intent)

We are biased and spread/teach propaganda

Disinformation = false information

Shared to influence public opinion; deliberately distorted, secretly leaked to deceive and manipulate

“fake news” is misused

Propaganda runs through most of our news sources — this is used as an argument to discount news sources and then say we can't trust anything we see or read.

Go back 2000 years - difficult to understand Pyrrhus - you have to discern what was happening though written from Roman point of view. You can still discern what happened.

The difficulty we have today, why it's an issue:

We no longer live in days of volcanoes and mushrooms clouds. It has been said it doesn't matter where you get your news from because if there was a volcano that erupted, and even if they approach it from a different perspective, news sources will all report the same thing. There was a volcano that you can see.

When it comes to discerning external events it doesn't look like that anymore. We're not required to discern something that obvious. War now isn't fought with machine guns. It's fought through information.

What was the purpose of the SU?....

It is not anonymous

Created partly by the government to be used in military.

An agent wanting to report back to US can be tracked— where he's been and where he's going. He can't sign into confidential website

2002 solved the problem:

Deep Web created by US Navy

TOR \*\* Created a new browser: TOR browser

No google, no search engine, everything is private

You have a ticket, but it's blank - free, anonymous, no supervision

The deep web, invisible web, or hidden web are parts of the World Wide Web whose contents are not indexed by standard web search engines. The opposite term to the deep web is the surface web, which is accessible to anyone using the Internet. Computer scientist Michael K. Bergman is credited with coining the term *deep web* in 2001 as a search indexing term.

The content of the deep web is hidden behind HTTP forms and includes many very common uses such as web mail, online banking, and services that users must pay for, and which are protected by paywalls, such as video on demand and some online magazines and newspapers.

The content of the deep web can be located and accessed by a direct URL or IP address, and may require a password or other security access past the public website page.

## Terminology

The first conflation of the terms "deep web" with "dark web" came about in 2009 when deep web search terminology was discussed together with illegal activities taking place on the Freenet and darknet.

Since then, after their use in the media's reporting on the Silk Road, many people and media outlets have taken to using 'deep web' synonymously with the dark web or darknet, a comparison some reject as inaccurate and consequently has become an ongoing source of confusion.

*Wired* reporters Kim Zetter and Andy Greenberg recommend the terms be used in distinct fashions. While the deep web is a reference to any site that cannot be accessed through a traditional search engine, the dark web is a portion of the deep web that has been intentionally hidden and is inaccessible through standard browsers and methods.

How do you access a page you want?

These websites are secret

Address is a random sequence of letters/numbers—you type code into browser

How to find out codes: depends on who you know

Chat groups, connecting with the right people, get codes and access websites

The US Navy had a problem:

If they had an agent in Russia and the TOR browser is on his computer, what will Russian government know?

If he has TOR browser, they know he works for US government

The US government is forced to make TOR browser public and popular. The more people accessing, the more hidden their work is. It is through the Deep Web, TOR that secret government business is done. Now that it's open and public it's used to the same extent by other world major powers. Most popular in Iran, Spain, France, Japan - Russia and US.

Paid by US - all can use it.

It's also used for illegal activities:

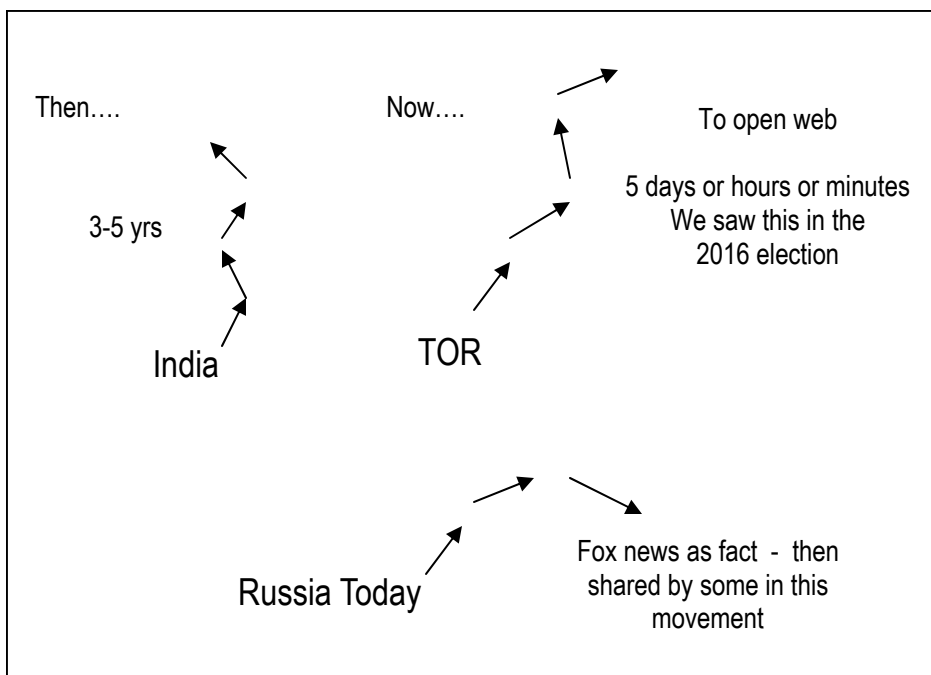
- ISIS
- Arms dealers
- Drug websites "Silk Road" the Amazon of drugs  
Silk Road creator serving 2 life sentences w/o parole

On these hidden sites you begin to see Russia share disinformation.  
40 years ago thru newspaper in India

Silk Road was an online black market and the first modern darknet market, best known as a platform for selling illegal drugs. As part of the dark web, it was operated as a Tor hidden service, such that online users were able to browse it anonymously and securely without potential traffic monitoring. The website was launched in February 2011; development had begun six months prior. Initially there were a limited number of new seller accounts available; new sellers had to purchase an account in an auction. Later, a fixed fee was charged for each new seller account.

In October 2013, the Federal Bureau of Investigation (FBI) shut down the website and arrested Ross Ulbricht under charges of being the site's pseudonymous founder "Dread Pirate Roberts". On 6 November 2013, Silk Road 2.0 came online, run by former administrators of Silk Road. It too was shut down, and the alleged operator was arrested on 6 November 2014 as part of the so-called "Operation Onymous". Ulbricht was convicted of eight charges related to Silk Road in the U.S. Federal Court in Manhattan and was sentenced to life in prison without possibility of parole

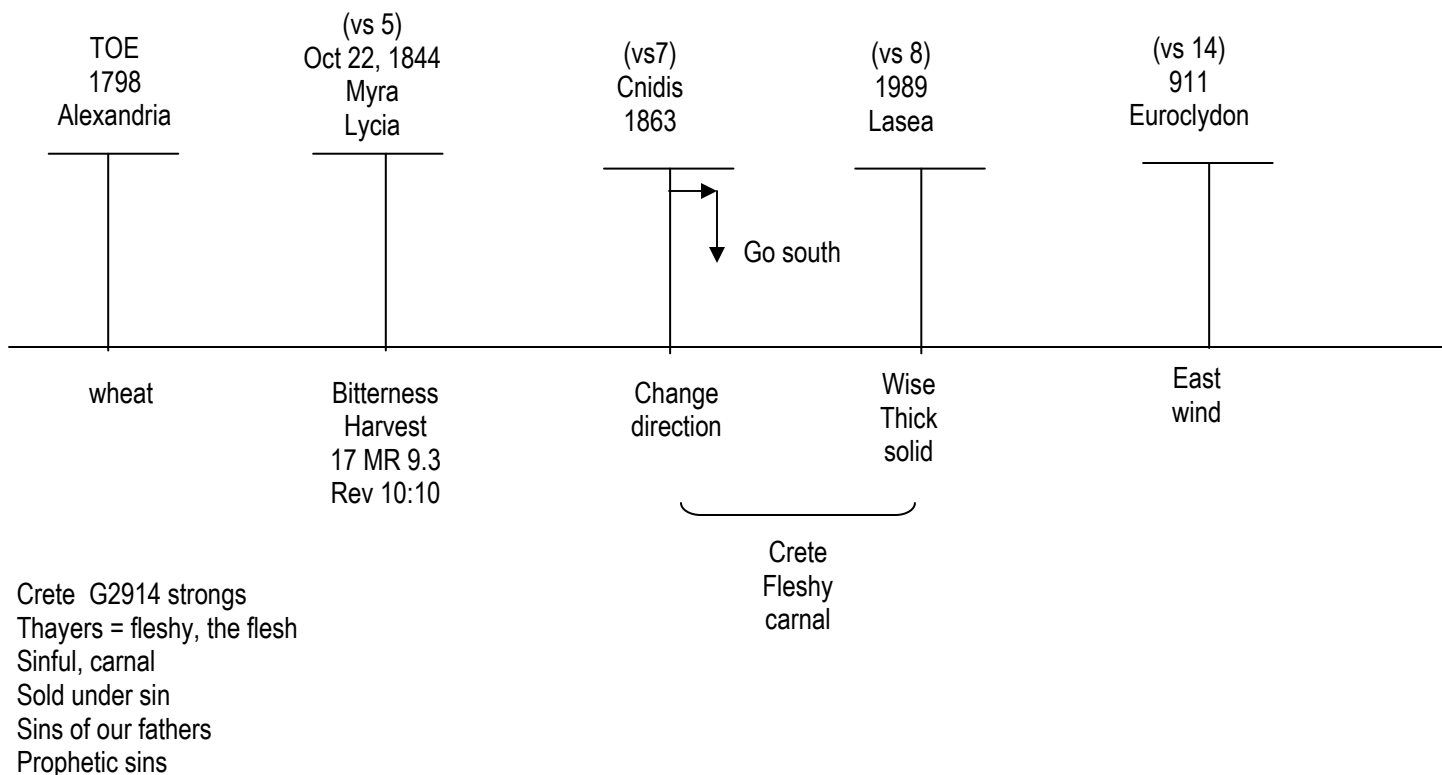

## Shipwreck = SL



### Salmōnē

sal-mo'-nay

Perhaps of similar origin to G4529; *Salmonē*, a place in Crete: - Salmone.

### alamis

sal-am-ecce'

Probably from G4535 (from the *surge* on the shore); *Salamis*, a place in Cyprus: - Salamis.

### alos

sal'-os

Probably from the base of G4525; a *vibration*, that is, (specifically) *billow*: - wave.

### ah'ee-no

Akin to G4579; to *wag* (as a dog its tail fawningly), that is, (generally) to *shake* (figuratively *disturb*): - move.

### seiō

si'-o

Apparently a primary verb; to *rock* (*vibrate*, properly sideways or to and fro), that is, (generally) to *agitate* (in any direction; cause to *tremble*); figuratively to throw into a *tremor* (of fear or concern): - move, quake, shake.
